Monsoon session of Goa Assembly curtailed due to panchayat polls

PANAJI, JULY 7 /--/ The monsoon session of the Goa Legislative Assembly, which begins on July 11, will be curtailed to two weeks in light of the upcoming panchayat elections. During a meeting of the Business Advisory Committee (BAC) on Thursday, Speaker Ramesh Tawadkar announced that the session will be curtailed to two weeks from the original plan of five weeks, due to the panchayat elections, scheduled to be held on August 10. Chief minister Pramod Sawant said the state machinery will be busy preparing for the panchayat elections and hence, it will be difficult to hold a full-fledged session of 25 days (five weeks). The Opposition leaders, however, have condemned the government's decision to restrict the session to two weeks. The state government had requested the Speaker to curtail the session to two weeks due to the workload on the government servants considering the upcoming panchayat election, Sawant said. It is easy for the Opposition to demand a full

session, but considering the workload it is not possible to hold it, the chief minister said, adding that it is mandatory for the government to pass a full Budget, which will be done during the session. The chief minister further said that it is wrong to criticise the state government for not holding a long session, as even in big states, there are shorter sessions. Opposition leaders from the Congress, Goa Forward Party (GFP), Aam Aadmi Party (AAP) and Revolutionary Goans Party have slammed the state government's decision. GFP chief Vijai Sardesai said that the Speaker and the government were killing democracy and setting wrong example for the newly elected MLAs by curtailing the session. The Opposition members had appealed to the Speaker that the session be held for two days and adjourned to be summoned again in September after the panchayat elections, Sardesai said. (PTI)

Punjab: 2 Nigerians held for duping govt officials by posing as cabinet ministers, bureaucrats

CHANDIGARH, JULY 7 /--/ Two Nigerian nationals have been arrested from Delhi for allegedly duping government officials and others of money by posing as cabinet ministers and senior bureaucrats, a police officer said on Thursday. They used to allegedly introduce themselves as VVIPs on WhatsApp and send messages to people, mostly government

officials, asking for financial favours in the form of gift cards and digital wallet payments among others, Punjab Director General of Police (DGP) Gaurav Yadav said. To make their WhatsApp profiles look genuine, they also used to keep images of those VVIPs as their display pictures, he added.

Anioke Hyginus Okwudili alias Poka and Franklin alias William, both residents of Lagos in Nigeria and currently

residing in Delhi, have allegedly duped several people by impersonating as Punjab cabinet ministers, DGP, chief secretary, and other IAS and IPS officers, Yadav said in a statement here. Police recovered expensive watches, mobile phones, laptops, gadgets, a debit card and passports from their possession, he said. Inspector General of Police (Cyber Crime) R K Jaiswal said teams from the Punjab Police and the Delhi Police managed to nab

Anioke red-handed while he was withdrawing money from an ATM kiosk located near Vikas Puri in New Delhi. "The WhatsApp accounts were hacked from Nigeria and he (Anioke) used to withdraw the money from the ATM cards of bank accounts opened using fake documents in different parts of the country. The money used to be then handed over the kingpin Franklin, who further used to electronically transfer the money to Nigeria," Jaiswal said. Franklin was also arrested in a joint operation by teams from the two states after a chase, he added. Another police official said the arrest of the kingpin with the recovery of almost 108 GB data opened a realm of information revealing the magnanimity of the financial transactions amounting to several lakhs

of rupees every day. "The information containing screenshots of the impersonated IDs and transactions has been sent

for forensic analysis for further probe into drug linkage and hawala transactions," the official said. (PTI)
